Early Childhood is an integral part of the Forest Lake Area School District and works closely with the K-12 programs to assure that children transition smoothly into kindergarten. Our high quality preschool classes focus on each child's social, physical and preacademic development. We use a play based curriculum allowing children to learn through exploration and discovery. Children develop independence and the necessary skills for future school success. All early childhood preschool classes are taught by licensed teachers who hold, at minimum, a four year degree.

We offer many options for families with preschool aged children. Preschool with Parents at all locations includes designated days that a parent or caregiver must attend with their child. Many classes are integrated with Early Childhood Special Education.

Preschool Facts

- " **Classes begin the week of September 10, 2012 and run for 30 weeks ending May 24, 2013**
- " **Non refundable registration fee of \$40 is due with registration**
- " **First tuition payment due at parent orientation in early fall**
- " **Tuition is payable in 9 equal payments Sept - May**
- " **Children must be appropriate age by September 1, 2012**
- " **Immunization records must be received to complete registration**
- " **We will continue taking registrations as space permits**

Sliding fee information

Preschool with Parents is open to all families in the community. Sliding class fees are available for qualifying families enrolling in Preschool with Parents. It is our goal that all children are able to attend preschool regardless of income.
